NOTIFICATION


In continuation to this office notification No.2598 dated 12.3.2022, it is notified that as per interim order dated 13.5.2019 issued by the Rajasthan Hon'ble High Court in No. SBCWP/6577/2019 (Niji College Shikshan Sansthan Welfare Society V/s NCTE and Anr.), Hon'ble Vice-Chancellor has been pleased to order that looking to the interest of the students, the order of the Hon'ble High Court and the present scenario of COVID-19, the private colleges already affiliated to this University is hereby granted temporary and purely provisional extension in affiliation for the session **2021-2022** subject to final decision of the Hon'ble Rajasthan High Court in abovementioned writ petition and with the condition that whenever COVID-19 situation improves, inspection of colleges will be done by the authorized Inspection Committee of the University and the colleges will have to submit an undertaking to the effect that they have no objection for such inspection and will pay penalty imposed by the University due to any lacuna/shortfall found by the Inspection Committees during proposed inspection in future.




